ROUND ROCK, TX DONATION PROGRAM

Thank you for allowing Kalahari Resort- in Round Rock, TX the opportunity to assist your organization! In order to accommodate the many donation requests received we have designed the following program to accommodate all fund raising organizations.

Our donation is in the form of a reduced room rate for two of our most popular rooms. Our Double Queen Sofa Room offers two queen beds and a sofa sleeper. This room will comfortably sleep four people and allows admission to our 223,000 square foot waterpark for all four guests. Our 2 Bedroom 2 Bathroom Living Room Suite is a two room suite that includes a king bed in the master bedroom, two queen beds in the second bedroom and a queen sofa sleeper in the living room. It also comes with three televisions and two bathrooms. This suite allows admission for five to the waterpark.

We would like to offer you the Double Queen Sofa Room at the much reduced rate of \$119.00 per night and our 2 Bedroom 2 Bathroom Living Room Suite at \$199.00 per night (tax and resort fee not included, see donation request form for details). Each certificate would be valid twelve months from the date of your function. Restrictions of use include weekends and holidays, and they would not be valid on any specified blackout dates (see below). Maximum purchase of one night per room type will apply for your event and organization.

Also available, we are offering water park day passes, which allows entrance into the water park at a reduced rate of \$20.00 per pass (limit is 6 total). These passes cannot be used on Saturdays and are limited to first come, first serve at the water park entrance. It is advised that the recipients of these passes call ahead to the water park front desk to ensure outside entrance will be available. The full restrictions and phone numbers can be found on the back of each pass.

Due to high demand, these gift certificates must be purchased by the organization hosting the event. If your organization qualifies for tax-exempt, you must include a completed 01-339 form in order to exclude the state sales tax from each rate.

Also required, will be a flyer promoting your event or a request for a donation on your organization's letterhead with the date of event as well as a copy of this letter. Purchasing the certificate can be done by credit card (please fill out the [credit card authorization form](#)) or mailing in a check or money order with the required documentation. Please complete [Donation Request Form](#) and mail the documentation to the donations address listed below. Certificates will be mailed out within two weeks after we receive your request and payment.
